

BIOGENETIC SEQUENCE OF DESCENT

FROM

AUD “THE DEEP-MINDED” TO BRITAIN’S KING JAMES

P1 AUD (“the Deep-minded”, a/k/a “Unn”) KETILSDOTTIR, by king Olaf the White, is mother to THORSTEIN the Red. (*Olaf “the “White”, a/k/a Anlaf Gothfrithson, was a Norse king of Dublin.*)

F1 THORSTEIN the Red, by Thurid of Ossory, is father to GROA THORSTEINSDOTTIR.

F2 GROA THORSTEINSDOTTIR, by Duncan of Caithness, is mother to GRELOD. (*This Groa stayed behind in Orkney, and married Duncan, as Aud’s extended family continued to flee north to Iceland.*)

F3 GRELOD DUNCANSDOTTIR, by Orkney’s earl THORFINN (I) “Skull-splitter” EINARSSON, is mother to earl HLODVER. (*Thorfinn I was son of earl Turf-Einar, who was son of Ragnvald “the Wise” of Møre.*)

F4 HLODVER THORFINNSSON, by Audna of Ireland, is father to earl SIGURD (II) “the Stout” Hlodversson.

F5 SIGURD II, by Donada of Scotland, is father to earl THORFINN (II) “the Black” Sigurdsson.

F6 THORFINN II, by Ingibjorg (“Earls’ mother”, and kin to Norway’s royal family) Finnsdottir, is father to earl PAUL (I) Thorfinnsson

F7 PAUL (PÅL) THORFINNSSON¹, by Håkonsdottir, is father to earl HÅKON Paulsson (born ~AD1070).

F8 HÅKON PAULSSON, by Helga, is father to INGIBJORG HÅKONSDOTTIR.

F9 INGIBJORG HÅKONSDOTTIR, by Olaf “the Red” (“Bitling”) Godredsson, is mother to RAGNHILD.

F10 RAGNHILD OLAFSDOTTIR, by SOMERLED, is mother to their children, and ancestress to their² posterity, including King James (“I” of England, “VI” of Scotland), who sponsored the KING JAMES BIBLE.

¹This Paul, with his brother Erlend, guarded Viking boats along with Olaf (III) Haraldsson (i.e., Hardrada’s son), whilst Norway’s Viking king Harald “Hardrada” fought and died at the Battle of Stamford Bridge (September 25th of AD1066). Since both this Paul Thorfinnsson and Olaf III Haraldsson are ancestors of King James, their survival obviously affected world history. E.g., Olaf III would not father Magnus (III) till ~AD1074, so the next biogenetic link in King James’ lineage chain comes 7 years after Olaf III survived the Battle of Stamford Bridge. Also, Paul Thorfinnsson, by Ragnhild Håkonsdottir, fathered Håkon Paulsson ~AD1070, (i.e, ~4 years after Stamford Bridge), and thereby contributed to the procreation of the next link in King James’ ancestral chain. Providentially, God ruled the details of human history and geography so that both Olaf III (Hardrada’s son) and Paul Thorfinnsson survived 9-25-AD1066 by at least long enough to extend their lineages to allow (eventually) for a common descendant, James Stuart, who would officially sponsor an “Authorized Version” of the Holy, the “King James Bible” of AD1611.

² As shown in *“To Globally Sow His Word, Did God Use Vikings?”* (page 5), Somerled and his wife (Ragnhild Olafsdottir) are **P14** ancestors to England’s King James I. As the above listing shows, Ragnhild Olafsdottir is an **F10** descendant of Aud Ketilsdottir. Thus Aud “the Deep-minded” Ketilsdottir is a **P24** ancestress to King James, and her nocturnal flight to Iceland (stopping at Orkney) was providential.
